

IS YOUR CHURCH CONSIDERING OFFERING SANCTUARY PROTECTIONS FOR IMMIGRANTS?

Additionally, "sanctuary" supports offered by churches in this era extend well beyond the form of offering housing within church facilities. Supports include what are being termed "sanctuary in the streets" models, where churches demonstrate solidarity with immigrants by offering help such as:

- -- Know Your Rights Training for immigrants and allies
- -- Rapid Response during immigration raids and pastoral care to families following raids
- -- Accompaniment with immigrants to ICE appointments
- -- Prayer Vigils, Press Conferences, and other expressions of public voice to support family cases
