



Disciples & Interfaith Toolkit: Top 5 Ways to Take Action NOW in 2018 #Faith4TPS

Temporary Protected Status, or TPS, is a life-saving immigration program that allows foreign nationals to remain in the U.S. if, while they were in the U.S., something catastrophic happened in their country of origin that prevented their safe return. TPS protects people from deportation and allows them to work legally while they remain in the U.S. Right now, TPS protects approximately 330,000 people in the U.S. who would otherwise be subjected to disease, violence, starvation, the aftermath of natural disasters, and other life-threatening conditions.

On September 18th, the administration terminated TPS for Sudan, effective November 2, 2018, despite ongoing conflict and displacement, while extending TPS for South Sudan for 18 months. **On November 6th, the administration terminated TPS for Nicaragua, effective January 5, 2019, and was unable to decide whether to extend TPS for Honduras, resulting in an automatic six-month extension until July 5, 2018.** Acting Secretary Duke signaled the possibility that the TPS designation for Honduras might also be terminated at the end of the six-month automatic extension. **Most recently, on November 20th, the administration terminated TPS for Haiti, effective July 22, 2019,** despite the ongoing hunger, displacement, and public health crises. The administration's decisions are cruel, inhumane, and immoral.

On January 8th, 2018, DHS terminated TPS for El Salvador, effective September 9th, 2019. As communities of faith, we urge the administration to reinstate TPS for El Salvador, Sudan, Nicaragua, and Haiti and extend TPS for Honduras for another 18 months, as the safe return of these individuals is forestalled by dire humanitarian circumstances. Terminating TPS designations places countless lives at risk of deportation back to life-threatening conditions and will tear TPS holder parents from their 273,000 U.S. citizen children. It will also separate families, devastate our economy, and destabilize regional security that drive displacement. **Next, DHS will determine whether to renew TPS for nearly 6,000 Syrians by January 30th!**

5 Ways to Take Action:

#1: [Click Here](#) to Urge Congress to Support TPS Holders!

Sample Script: "I'm your constituent from [CITY/TOWN], I support Temporary Protected Status (TPS) for my Salvadoran neighbors, and I oppose the administration's recent decision to terminate it. I urge you to do everything in your power to see that the administration reinstates TPS for El Salvador for another 18 months, and to issue statements and make floor remarks supporting Salvadoran TPS holders. I call on you to demonstrate bold leadership and support a permanent, legislative solution that protects all TPS holders from being separated from their families. My community welcomes immigrants, and I urge you to reflect the best of our American values of compassion and welcome."

#2: **Join the Prayer Chain and Share on Social Media**

Take over social media with our prayers with all TPS holders and offer prayerful witness to defend TPS:

1. Record a **video** of yourself holding a printed, filled out **#Faith4TPS sign**: [PNG](#)

3. Post the video to **Instagram** and **Facebook** with **#Faith4TPS #SaveTPS #ProtectTPS**. Make the post public on Facebook and tag Interfaith Immigration Coalition and your Members of Congress!

#3: Organize Local #Faith4TPS Events

1. Engage your Members of Congress and their staffers in conversations and visits about what you have learned--and especially share stories of TPS recipients who may be in your congregations!
2. Consider connecting with local TPS holders and holding a vigil on your college or university campus in support of TPS for Hondurans, Nicaraguans, Salvadorans, and Haitians. Invite Congress members/staff to attend these events!
3. Promote your actions with local media outlets. (*How-to guides contained in the toolkit.*)

Use the **Interfaith Immigration Coalition's [Toolkit to Defend TPS](#)** to incorporate TPS holder stories and solidarity into your faith-led advocacy, worship services, scripture study, educational events, vigils, and public witness.

#4: Write for Media

Elevate the public call by publishing a letter to the editor ASAP condemning the TPS termination for El Salvador, urging the administration to reinstate the designation for another 18 months, and calling on Congress to pass a permanent solution for TPS holders.

1. Include your faith tradition, scriptural grounding, and congregational affiliation to demonstrate your connection to the community.

2. Call on your Member of Congress (**by name!**) to work to support legislation that would protect TPS holders from deportation, and do everything they can to see the administration reinstate these designations, and calling on Congress to pass a permanent solution for TPS holders.

#5: Write & Share Press Releases Denouncing Termination

Press releases increase public education and raise the public profile of why TPS is important to our communities. We encourage faith organizations to take a public stance urging the administration to extend TPS for El Salvador for at least another 18 months. TPS Press Release Template:

Headline: [Faith organization denounces the administration's decision to terminate Temporary Protected Status for El Salvador]

[FAITH ORGANIZATION] condemns the administration decision to end Temporary Protected Status (TPS) for El Salvador. TPS protects individuals and families who would otherwise be in harm's way in their countries of origin, which are recovering from catastrophic events such as natural disaster, war, famine, or disease. As [PEOPLE OF FAITH] we believe in the dignity of human life and denounce this decision to return people to conditions where their lives will be immediately put in danger.

[INSERT QUOTE FROM LEADER OF YOUR ORGANIZATION describing country conditions--check recent reports from the United Nations or International Office of Migration--and stating that returning people to those conditions is a violation of American, moral, and faith values.]

[INSERT QUOTE FROM TPS HOLDER or family member of TPS holder in your congregation or community and what it means to have to leave the U.S. and return to unsafe conditions.]

[INSERT QUOTE FROM LEADER OF YOUR ORGANIZATION about concern with breaking up families and removing people from their communities. **End by calling on the administration to reinstate TPS for El Salvador and urge Congress to act to provide a permanent solution for TPS holders.**]
